

Sav-A Step Gem Multiplier 2nd Chance Sweepstakes Official Rules

1. **HOW IT WORKS:** From October 1, 2019 – October 31, 2019, or while supplies last (“the Sweepstakes Period”), contestants may visit participating Sav-A Step (“Sponsor”) locations and enter for a chance to win one of the prizes specified below. The odds of being selected as a winner depend upon the number of entries throughout the duration of the sweepstakes.
2. **ELIGIBILITY:** Only open and offered to legal U.S. residents who reside in Indiana and who are 18 years of age or older at the time of entry. Only \$5 - Sapphire Mine 20X and \$10 - Diamond Mine 50X Scratch-off tickets are eligible and, therefore, will earn entries into the Sweepstakes.
